Nov. 6-17, 2017 Sweepstakes Rules

4. Sweepstakes Period

The Sweepstakes begins on November 6, 2017 at 7 a.m. Pacific Standard Time and ends on November 17, 2017 at midnight Pacific Standard Time (the "Sweepstakes Period"). Entries that are submitted before or after the Sweepstakes Period will be disqualified. Submissions will be accepted for the duration of the Sweepstakes using any of the following methods:

5. How to Enter

Via Text Message: This method of entry will be available for the entire Sweepstakes Period. Send a text message with Clackamas from your handset to the short code 31996. In response to this text message, an auto-reply will be sent to the device. Follow the directions provided in the reply to confirm your entry. Standard text and data rates will be charged for each text message sent or received from your handset according to the terms of your carrier. 6. Prize Drawing

7. Winner Notification

The potential winners will be notified by email, mail, phone, or text message. Each potential Grand and First Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize. 9. General Conditions
