



## CCC IN GLADSTONE

2022 Gladstone population estimate: **11,996**



### High School Connections

CCC partners with over 40 high schools to offer students the chance to earn college credit for free or at a highly discounted rate. Programs include Advanced College Credit, Expanded Options/ Early College Program, Career Technical Education Pathways and High School Plus.

- Of the 19,857 CCC students (total for 2022-23), **564 were from Gladstone.**
- **66 Advance College Credit students** from Gladstone High School in 2022-23 earned 646 credits, a tuition value of \$69,122.



### Workforce and business connections

- **15 Gladstone businesses** were served by the Small Business Development Center in 2022.
- Over the past five years (2018-2022), CCC offered **184 customized training sections**, enrolling 1,019 students with an average annual participation of 231.
- In 2022, the Small Business Development Center served **437 clients** from Clackamas County and veterans in the Portland metropolitan area, with 51 training events and 596 attendees.
- SBDC provided **1,732 free hours of business counseling** and assisted with **44 business startups** and **\$4,144,770 capital infusion**, with **124 jobs created.**

### Tuition comparison



Starting a four-year degree at Clackamas Community College can save students thousands of dollars on their cost of education.

#### 2023-24 average cost of tuition and fees comparisons:

- Average Oregon **four-year private university** tuition and fees \$42,100
- Average Oregon **four-year public university** tuition and fees \$13,760
- **Clackamas Community College** tuition and fees \$6,210

Annual tuition and fees at CCC and Oregon four-year public and private universities is based on figures provided to the Oregon Office of Student Access and Completion by the institutions. OSAC NOTE: These "standard" undergraduate student budgets are for informational purposes only. They are based on full-time enrollment at 15 credit-hours/term and do not include insurance, loan fees, non-mandatory fees, or special program-specific fees. Actual budgets will vary from these "standard" budgets, depending upon program of study, course load, dependency status, and housing situations. (For certain programs, course loads may be restricted to less than 15 credit-hours per term.)



### Student access for 2022-23

- **Tuition** was \$117 per credit for in-state students.
- **Financial Aid:** The total federal and state aid students received was \$8,878,419.
- **Scholarships:** The total in scholarships and waivers students was \$1,973,711.
- The **CCC Foundation provided \$1,025,666** in scholarships to students, funded through private donations, in 2022. **The average award per student was \$2,275. One in three applicants (37%) were awarded a scholarship.**

### Economic impact

- In 2021-22, CCC added **\$314.7 million** in income to the county's economy, a value equal to ~1.2% of the county's total gross regional product. Expressed in terms of jobs, CCC's impact supported 3,962 jobs. For perspective, the activities of CCC and its students support **one out of every 63 jobs in Clackamas County.**
- In return for their investment, students receive a cumulative value of \$169.3 million in increased earnings over their working lives. This translates to a return of **\$4.20 in higher future earnings** for every dollar students invest in their education.
