#### Can I be enrolled part-time?

**Admission Policy Statement**

*Clackamas Community College is approved by the U.S. Department of Homeland Security (DHS) to admit qualified students from other countries. International students may be admitted to the college if they meet all CCC's International Student Admissions Requirements. International students are required to maintain a minimum 2.0 GPA and complete at least 12 credits each term for college level students and 18 hours/week for Program for Intensive English students.*
